6. NORTH LINCOLNSHIRE COUNCIL MATTERS

- iii) Planting of bulbs – verification is still required as to if and where it is permissible to plant bulbs on the Ashfield site. Cllr Waters will look into where to purchase the bulbs from. It was suggested that bulbs should also be supplied to Lindsey Lodge Hospice and Carisbrook Manor Care Home.
- iv) New matters: A discussion took place regarding the proceeds of the raffle on the coach trip and what this money should be used for. The meeting agreed that this was not a parish council decision to influence or make.

The lagoon is being used by fishermen who are aggressive and threatening in their manner and are leaving rubbish/litter. The IDB are not interested in erecting signs to dissuade fishing in the lagoon and the meeting concluded that there was not a lot to be done to improve the situation – although it is recommended not to confront people at the lagoon.
