DDM anticipate submitting the application to N.L.C in early spring once all the information has been collated. Parish Councillors expressed their concerns regarding traffic generation which would adversely affect Scotter Road and Burringham Road. Ms Heaton advised that a traffic assessment will be taking place. A public consultation will take place tomorrow – 9/1/19 at The Golf Club to which members of the public are invited.
