7. North Lincolnshire council matters:

- a) Report from Ward Councillor J Walshe : Cllr Walshe advised the meeting that a meeting with the bus service department recently had gone very well and most of the requirements asked for by the residents have been provided. Cllr Walshe advised the meeting that building of the first phase of the Lincolnshire lakes project was very close and he hoped to press for a 30mph speed limit all along Burringham Road. Cllr Walshe advised the meeting that investigations are arranged to look at the surface water problem on Woodside Drive – a meeting with the site developer has been arranged.

The airfryers, slow cookers and one cup kettles have been delivered to the over 80 year olds before Christmas, further deliveries have been delayed due to Cllr Walshe accident. Some residents have collected their devices and the remaining will be delivered shortly. Cllr Walshe advised that remaining items are still available for anyone who didn't apply in time initially. The 'Just Go' bus service will be replaced in September with a new supplier who has a good track record of delivering this service.

- b) Any new N.L.C matters to report: Cllr Holloway advised the meeting that the dyke running from the pond to Scotter road pumping station is being filled with debris by children/youths. This needs clearing out and Cllr Walshe was asked to establish who owns this dyke and arrange clearance.

8. Parish Matters

- a) NATS meeting – The next NATS meeting will be held on 17th June in Gunness Village hall at 5.30pm. It was noted that nuisance electric bikes are proving problematic – they are quiet so the Police are having difficulty establishing where they are and are very difficult to track. The Police need to be informed when and where they are so that they can attend. It was noted that the cctv camera near the skip has been thrown into the lagoon.
- b) Neighbourhood Watch Schemes : Both schemes are still operation but everything is quiet at the moment.
