#### 7. North Lincolnshire council matters:

- a) Report from Ward Councillor J Walshe: Cllr Walsh advised the meeting that he attended the parish V E Day celebrations which was a thoroughly enjoyable event, well organized and well attended. The Southern roundabout has now been constructed and is functional, work on the associated connections will commence in 4/6 months.
- b) Surface Water problem Woodside Drive: N.L.C drainage team and representatives of Persimmon Homes have inspected, acknowledged that the drains and fall are in the wrong place, areas have been marked up for remedial works.
- c) Dyke Pond to Scotter Road pumping station discussions are still ongoing as to who has responsibility for this dyke N.L.C or I.D B.
- b) Any new N.L.C matters to report: A hedge is encroaching the pavement towards Silica Lodge, Cllr Walshe will ask the farmer to cut this hedge back.

#### 8. Parish Matters

- a) NATS meeting The NATS meeting was held on 17<sup>th</sup> June in Gunness Village hall at 5.30pm. Unfortunately The Police could not attend this meeting due to attending to another matter however no matters affecting this parish were raised. The date and venue for the next meeting has yet to be decided.
- b) Neighourhood Watch Schemes: It was reported that the Parklands and Ashfield neighbourhood watch schemes have amalgamated and will work together in the future. Social events are currently being discussed.

The meeting felt a local connection would be more suitable with Lincolnshire lakes/ rivers/ water courses used for road names. Clerk to relay this to N.L.C.
